FROM THE PRESIDENT

As the weather cools, the road race season kicks off for local runners and walkers, and a couple of upcoming events have asked for our help. September 9th, the club has agreed to support the Charleston Running Club in staging the Charleston 9 Memorial Run. This charity run/walk will benefit the families of the nine Charleston firefighters who lost loved ones in the tragic Sofa Super Store fire on June 18th. All proceeds will go to the South Carolina State Firemen's Association Endowment for the Charleston

Firemen's Fund. On October 6th, the club will assist the Mt. Pleasant and Isle of Palms Exchange Clubs in conducting the Isle of Palms 5K/10K Run that benefits the Exchange Club Center for the Prevention of Child Abuse. Another great benefit of the IOP run is the chance for some fellowship after the race at the Sea Biscuit Cafe – an island icon with some of the best omelets around.

The remnants of Hurricane Dean have now dissipated, but it was our warning shot for what may be a particularly active Atlantic hurricane season. During Dean, hams were involved in supporting the National Hurricane Center and passing vital traffic from the affected areas. Locally, several agencies have begun to look at amateur radio as part of their disaster preparedness planning. On August 22nd, I was asked by the East Cooper Community Outreach (ECCO) organization to come speak about amateur radio, and how it might help coordinate the various church and other volunteer groups involved in this agency's support for food and medical supply distribution in the East Cooper area. It was a great meeting, and had the bonus benefit of being filmed by the local Channel 2 news folks. I didn't plan on an interview, but the reporter was so interested that he followed me out of the room to carry on the dialog, and we got a little bit of media attention on that evening's news to boot! We will again have the chance to expose the public to amateur radio at the upcoming Coastal Carolina Fair. Again this year, CARS will host a booth throughout the Fair.

MINUTES of AUGUST MEETING

MINUTES:

The Charleston Amateur Radio Society meeting was called to order by President, Ken Bible, AF4ZV, at 7:30 PM on August 13, 2007 at Ryan's Steak House, in Charleston.

Introductions:

There were 38 members and 7 guests present.

Secretary's Minutes/ Report: Tracey KG4HTW In a motion by, Bill Pennekamp (WA4WGP), and second by Peggy Thorne (KD8FNK), the July 2007 meeting minutes were approved as published in the August 2007 CARS Carrier with the amendment that the call sign for Elizabeth Zahrn be corrected to read KI4RRZ under the membership section.

Treasurer's Report: Linda K4MPY

The July 2007 Treasurer's report was accepted as information, as published in the August 2007 CARS Carrier.

Hamfest Report: Jenny WA4NGV

Jenny reported that she had received a letter from the ARRL confirming that the CARS Hamfest was once again approved for the ARRL State Convention.

Flyers for the 2008 CARS Hamfest should go out this week.

Field Day: Doc W4MUR

Doc thanked all who helped with Field Day. He thanked in particular, Tim (KD5YUC) and Linda (K4MPY). Tim was participating in his first Field Day, but compiled the results and assembled them for submission to ARRL. Tim reported that the club completed 270 CW QSOs, 439 digital QSOs, and 694 phone contacts. The club received 1060 bonus points. Our point total for Field Day was 2624. It was noted that the club did not receive any points for the GOTA station due to the rule that each operator must make 20 contacts to qualify for the 20 points. (AF4ZV) thanked everyone for their help, and particularly thanked Doc for being the club's Field Day Captain again this year.

Ken (AF4ZV) reported on an invitation he had received to come speak to the East Cooper Community Outreach (ECCO) organization which has requested information about amateur radio in emergency services.

Repeater Report: Bryce K4LXF

Bryce reported extra fun with repeaters since the last meeting. He reported that Saturday night (August 11) there were numerous hang- ups and time-outs on the repeaters. Sunday morning, he realized that the link system was down. He made a trip to the Knightsville repeater site and found that the repeater was staying The repeater was uninstalled and "keved up". checked out, and it checked out fine. After some additional trouble shooting, it was realized that there was a weak, but good steady carrier being received on the up-link frequency. It was determined that the Seabrook repeater link was locked up on 446.45 Mhz. The problem was corrected by taking down the link.

A new repeater had already been planned and purchased for the Seabrook site, and is ready for installation, which should resolve the problem with the linked system once installed. Ken (AF4ZV) thanked Bryce for the detective work, and diligence in diagnosing the problem. He continued by noting the hard work by the club engineers in keeping the repeater system operational for the benefit of the whole club.

He encouraged Hams to set up a station to show scouts amateur radio. He also asked those operating to listen or call for "CQ Jamboree" in order to participate. Oscar gave some information on several sites that have regularly set up stations for JOTA. Wadmalaw Island will have a site, and Walterboro is looking for a site and operators. Ken (AF4ZV) noted that David Wilkins has helped in the past in arranging for operations on USS Yorktown. It was noted that arrangements could be made to allow scouts access to Yorktown to operate amateur radio for JOTA.
