# **EMERGENCY PREPAREDNESS**

Welcome to May 2020. The Low Country is now one month away from the start of the 2020 Atlantic Hurricane season. According to the National Hurricane Center they expect an active year in storms and now is the time to prepare. COVID 19 has drained supplies and frustrated many people but the hurricane season will still arrive and everyone needs to plan and put your plan into action. Because of this please remember that Charleston County has recertified more shelters than ever before. These shelters will be opened pre landfall and stay open post storm as needed for damaged residences. Overflow will be sent to upper Berkeley County shelters so Amateur communicators will be needed in ALL Low Country shelters. A secondary assignment may involve Hospitals too. The South Carolina Healthcare Emergency Amateur Radio Teams (SCHEART) system could be utilized if communications are lost due to damage or flooding of underground lines so prepare for both shelter duties or hospital duties in the Low Country.

Preparedness for the two potential assignments is similar and yet different. Shelter duty will involve having back-up Communications equipment to supplement deployed or installed equipment. Charleston County is building deployable kits that have a 2 Meter radio, antenna with magnetic mount, and a power pack that recharges from 120 volt AC, 12 volt DC, and has a solar panel too. The radio will be pre-programmed for local repeaters and have the list of programmed memories and the manual included. Remember you are supposed to be selfsupported for the first 72 hours, your own food, water, clothes, etc., etc. Volunteers will be needed after that first 72 hours as well because recovery could take a long time before the shelters close.

Hospital assignment WILL require a good handheld (HT) and spare battery packs or a charging system. Most hospitals have installed radio equipment but mobility around the hospital will require the HT. Some hospitals have repeaters that any HT can reach directly but some may require a relay from HT to Installed radio. Again arrive with 72 hours of self-support the Hospital will be busy helping the community and the staff, you are an additional load, be an asset not a load.

Another assignment may be as a relay station. During Hurricane Hugo many of the public service towers went inoperative. Either damage to the towers, or loss of power, or flooded fuel tanks for back-up generators, etc., etc. Be prepared to accept traffic and to relay to County Emergency Operations Centers. You may be deployed to a location between two stations that cannot communicate directly, for example the VA Hospital downtown Charleston can NOT contact the Primary County EOC on a simplex frequency but a station located at Dorchester Road and Leeds could hear both the VA Hospital and the Primary EOC acting as a relay.

Notice I referenced the Primary Charleston County EOC. There are two active EOC's in Charleston County, the Primary EOC is on Palmetto Commerce Parkway in North Charleston across from the Daimler factory. The Alternate EOC is in the Lonnie Hamilton building on Bridge View Drive (off of Leeds Ave). Either one or both could be activated during an emergency so operations from both sites would require additional hams.

Expect the National Hurricane Center to test its equipment before the season starts. Frequency for NHC is 14.325 USB on 20 Meters and 7.268 LSB on 40 Meters. Listen for the test when posted on the website: <u>www.nhc.noaa.gov</u>

## Looking for Amateur Support for Current MARS Exercise

MARS (Military Auxiliary Radio System) is a Department of Defense-sponsored program that provides contingency HF radio communications to DoD and Military Services utilizing volunteer amateur radio operators. Exercises focus on training that could support DoD missions of Humanitarian Assistance and Disaster Relief. Typical exercises involve MARS members collecting information about infrastructure status that might be used for planning DoD assistance in a regional situation and generating message reports back to the requesting "customer."

MARS is a "force multiplier" since members can extend their range of information gathering by reaching out to amateur community. That is the objective of this request. The current exercise involves reporting electrical power status. Request those who are interested report the following information by phone or by email to me at: <u>K8UM@ARRL.NET</u>
